PROPOSED AMENDMENTS TO THE STANDING ORDERS AND RULES OF THE RODRIGUES REGIONAL ASSEMBLY

By adding after Standing Order 65. House Committee, a new Standing Order 65A: -

65A. Sustainable Development Goals Committee

- (1) There shall be a committee to be known as Sustainable Development Goals Committee or SDG Committee, whose objective shall be to provide legislative oversight towards the achievement of the Sustainable Development Goals (SDGs) targets set forth under Agenda 2030 of the United Nations General Assembly.
- (2) The Committee shall consist of the Chairperson, the Deputy Chairperson and not more than five other Members to be elected by the Assembly. A quorum shall consist of 5 members.
- (3) Where the Chairperson, or in his absence, the Deputy Chairperson, is unable to be present at any meeting, the Committee shall elect a chairperson for the day only.
 - (4) It shall be the duty of the Committee to
 - (a) recommend the carrying out of
 - (i) baseline research on the status of implementation of the Targets of the SDGs;
 - (ii) periodical assessments of policies for strategic alignment to the SDGs and identifying gaps impeding on the achievement of the SDGs;
 - (iii) data gap analysis within the national statistical framework on the SDGs; and
 - (b) facilitate networking with civil society organisations and institutions in Rodrigues and abroad for capacity enhancement in all such activities,

with a view to achieving the SDGs.

- (5) The Committee shall, in discharging its duties under this Order, have power to engage into agreements, as required, with such stakeholders, including civil society and private entities.
- (6) The Committee shall, as and when necessary, lay a report outlining its activities, achievements and recommendations in the Assembly.
