To ask the Commissioner for Health and Others: -

Whether, in regard to the prevalence of fever in Rodrigues, he will state and table the number of reported cases for the months of October, November and December for the year 2022 and 2023?

To ask the Commissioner for Health and Others: -

Whether there has been a resurgence of dengue fever in Rodrigues and, if so, to state to the House:

- (a) on when the first case was detected, the total number of tests performed and cases detected, and the number of active cases as at date;
- (b) the number of patients currently isolated, specifying the different locations where isolation is being carried out, and
- (c) the measures implemented by his Commission to control the vectors responsible for the propagation thereof?
