Questions addressed to Commissioners

B/39 The Minority Leader (Mr. G. Jabeemissar)

To ask the Chief Commissioner:-

Whether, in regard to salaries paid to Pre-Primary school teachers in Rodrigues by the Rodrigues Regional Assembly, he will, for the benefit of the House, state:-

- (a) the recommended scale thereof, indicating if all teachers concerned are being paid the same salary and, if not, why; and
- (b) the conditions attached for the payment thereof indicating the item vote for its payment?

To ask the Chief Commissioner:-

Whether, in regard to demonstration plots and breeding centres owned by Rodrigues Regional Assembly, he will state the:-

- (a) number under operation in each case indicating their locations;

- (c) amount of money spent yearly since 2012 to date for running of these services indicating the policy of this Regional Government regarding same?
