Questions addressed to Commissioners

B/1 The Minority Leader (Mr. G. Jabeemissar)

To ask the Chief Commissioner:-

Whether, in regard to the passage of cyclone Bansi in Rodrigues, he will state on the:

- (a) different sectors which were mostly affected and to table the amount and cost of damages incurred to the economic sectors, buildings and public infrastructure, if any;
- (b) measures this Regional Government intends to take, if any, to mitigate the effects of flood on "radiers" and other prone areas of the island; and
- (c) compensation, if any, paid or to be paid to those severely affected and, if so, the different criteria applied regarding the payment thereof?

To ask the Chief Commissioner:-

Whether, in regard to the Programme Based Budget (PBB) 2014, he will, for the benefit of the House, state:

- (a) the financial situation of the Rodrigues Regional Assembly as at 31 December 2014 and to table a copy thereof;
- (b) if all the committed infrastructural projects and other programmes announced in the 2014 budget have been completed by the end of the fiscal year and, if not, to give the reasons therefor; and
- (c) the amount disbursed on each project so far and how the outstanding balance, if any, will be paid and to table a copy of same?

Whether, in regard to the construction of a new secondary school at Pistaches as announced in the Budget Speech 2015, he will, for the benefit of the House, state:

- (b) if any family/ies found within the perimeter or close vicinity of the proposed school will be relocated and, if so, where and under which conditions; and
- (c) if there are any agricultural lands found thereat which have been vested for the construction thereof and, if so, the modalities put in place for the compensation of these planters, if any?

- (d) table a copy of the conditions attached, if any, for the construction thereof?

- (c) if the contract of the consortium J.V Hydro Plumbing Co. Ltd/ Ocean Five Ltd has been terminated and, if so, since when and to give details about the contract and to table same?
