Questions addressed to Commissioners

B/121 The Minority Leader (**Mr F. A. GRANDCOURT**)

To ask the Chief Commissioner: -

Whether, in regard to maritime surveillance for vessel traffic monitoring and security, he can give details about the actual situation in Rodrigues and the measures his office is taking to strengthen same, if any?

B/122 The Fourth Island Region Member (**Mr. J.R. AUGUSTIN**)

To ask the Chief Commissioner: -

Whether, in regard to pre-primary schools in Rodrigues, he will, for the benefit of the House, state and table: -

- (a) the number thereof that are over-populated indicating, in each case, the number of classes, teachers and children concerned respectively;
- (b) if all buildings are equipped with a valid fire certificate; and
- (c) the detailed list of indoor and/or outdoor games available at each school?

To ask the Commissioner for Information Technology and Telecommunication and Others: -
