To ask the Chief Commissioner: -

Whether, in regard to the setting up of an office of the Economic Development Board (EDB) in Rodrigues, as recently announced by the Minister of Finance, he will, for the benefit of the House, obtain information from any relevant authority to:

- (a) state the objectives thereof; and
- (b) table any correspondence between his office and the EDB or any other office in Mauritius prior to the setting up of same?
