Questions addressed to Commissioners

B/94 The Fifth Island Region Member (Mrs M. A. L. ALLAS)

To ask the Commissioner for Agriculture and Others: -

Whether, in regard to the production of maize in Rodrigues, he will (a) submit the figures of the yearly production of this agricultural crop for the last ten (10) years (b) state the root cause of the decrease in production and (c) indicate measures that his Commission proposes to take to reverse the trend?

To ask the Commissioner for Fisheries and Others: -

Whether, with regard to the Octopus Second Opening Season 2025, he will indicate (a) the quantity of octopus caught during the first three days as compared to 2024 (b) the quantity of octopus exported to Mauritius and (c) when the report of the Professor Warwick SAUER will be submitted?
